
The parties pushing forward the vaccination agenda (including Big Pharma):

# PART I VACCINES AND THE VACCINATION AGENDA

## A. THE TRAGIC TRUTH ABOUT VACCINES



### VACCINES ARE NEITHER SAFE NOR EFFECTIVE!

FACTS your doctor either doesn't know or refuses to tell you:

- \* Vaccines are made from lab-altered and/or genetically engineered pathogens grown in animal blood cultures, including aborted human fetal cells.
- \* Vaccine cultures are preserved with neurotoxins such as mercury, formaldehyde, phenol, aluminum and MSG. These toxins are directly injected into babies, children and adults, bypassing the body's built-in protective systems.
- \* Vaccines containing proteins and oils are injected also bypassing the digestive tract where they would normally be processed. The body's immune system responds to them by over-producing antibodies, which in turn causes the high number of allergies we see today.
- \* Childhood vaccinations are the first assault on the normal functioning of the body, often creating neurological damage and degradation of the immune system.
- \* Vaccines are frequently administered in combinations (see **The Vaccination Schedule** on next page), like the measles, mumps and rubella (MMR) vaccine, subjecting children to multiple viruses at one time that would never be found together in a natural setting.
- \* Giving multiple vaccines at once makes it impossible to determine which one is most responsible for any adverse reaction.
- \* Children today are dosed with many vaccine antigens by age six. With repeated exposure the damage caused by vaccines can lead to developmental problems including autism, behavioral difficulties and auto-immune diseases.
- \* Neither polio nor smallpox were eradicated by vaccines. Smallpox and other infectious diseases were already declining - before vaccines were introduced on a large scale - due to increased nutrition and hygiene in most countries.

## C. THE HARSH REALITY OF THE VACCINATION AGENDA

The medical industrial complex has been peddling vaccines for decades, as they are a win-win for them. Physicians profit nicely from the wellness visits designed to implement the CDC's immunization schedule. And, lobbying efforts to get state legislators to require vaccines for school attendance have been quite lucrative for Big Pharma.<sup>8</sup>

In 1986 (32 years ago) Congress passed the National Childhood Vaccine Injury Act (NCVIA) removing liability from Big Pharma when their vaccines cause injury. They also created an injury fund - paid for by a surcharge tacked onto the sale of each vaccine - and a kangaroo court that awards damages to moms and dads when their sons or daughters are injured by these products. By 2013 nearly \$3 billion dollars had been paid out of this fund.<sup>9</sup> That represents A LOT of vaccine-caused harm to innocent children.

Your doctor never told you this, did he/she?

In 2011 the Supreme Court of the United States decided a case (*Bruesewitz vs. Wyeth*) that gave Big Pharma total immunity from liability even if they knew their vaccine product was defective. This bold decision transformed vaccines into what can now be accurately described as unwarranted pharmaceutical products. They were given a total exemption from all liability.

Your doctor never told you this, did he/she?

Vaccinations are the only medical procedure or drug that does not require informed consent.<sup>10</sup> While the Centers for Disease Control provides Vaccination Information Sheets, they readily admit these info sheets do not constitute informed consent. Physicians rarely offer parents/patients the package insert (which reveals severe side effects) prior to inoculation. In fact some physicians (and pharmacists) refuse parents/patients requests to see them. There is no federal law requiring them to make that information available.

Your doctor never told you this, did he/she?

According to the World Health Organization vaccine science is "consensus science".<sup>11</sup> Consensus science is created through the manipulation of groups of people by trained facilitators. The group is cherry picked, the material they review is cherry picked and the process is designed to achieve a predetermined goal. The process was created by a private think tank, the RAND Corporation, to do exactly what it does, i.e. give the false impression that an unbiased group of well informed people have thoroughly reviewed scientific data, a plan, or policy and have overwhelmingly come to a conclusion. The process of achieving consensus is a sophisticated technique of perception management known as the Delphi Technique.<sup>12</sup> Consensus science is not reached via the scientific method. Real science is replicable. Consensus science is not *real* science.

Your doctor never told you this, did he/she?

There is much your doctor hasn't told you and a lot he/she doesn't even know. In fact there is much that most people don't know about the vaccination agenda because it is not in the best interest of the players pushing it to tell us or our doctors.

## Moving the Vaccination Agenda Forward

According to the Office of Disease Prevention and Health Promotion of the United States:

*In the coming decade, the United States will continue to face new and emerging issues in the area of immunization and infectious diseases. The public health infrastructure must be capable of responding to emerging threats. State-of-the-art technology and highly skilled professionals need to be in place to provide rapid response to the threat of epidemics. A coordinated strategy is necessary to understand, detect, control, and prevent infectious diseases.*

- *Providing culturally appropriate preventive health care is an immediate responsibility that will grow over the decade. As the demographics of the population continue to shift, public health and health care systems will need to expand their capacity to protect the growing needs of a diverse and aging population.*
- *New infectious agents and diseases continue to be detected. Infectious diseases must be looked at in a global context due to increasing:*
  - *International travel and trade*
  - *Migration*
  - *Importation of foods and agricultural practices*
  - *Threats of bioterrorism*
  - *Inappropriate use of antibiotics and environmental changes multiply the potential for worldwide epidemics of all types of infectious diseases.*

*Infectious diseases are a critical public health, humanitarian, and security concern; coordinated efforts will protect people across the Nation and around the world.*

The page that these quotes are from represents the **Healthy People 2020** program currently being implemented. The page (link below<sup>13</sup>) also contains many very questionable statistics. In fact all statistics quoted regarding the 2009 H1N1 ‘pandemic’ are extremely doubtful. When journalist Sharyl Atkisson of CBS attempted to get accurate statistics, the CDC was unable to provide them<sup>14</sup>. Unfortunately her noble efforts resulted in the loss of her job. Yet, the unsubstantiated 2009 pandemic is still cited as a legitimate event to justify the ever expanding surveillance and vaccination programs being funded today.

**Nationally** - The **Healthy People 2020** program is being conducted by a group of unelected entities who have come together to form a public-private partnership.<sup>15</sup> These partnerships between government entities and private corporations are sold to the public as good things, when in fact they are a way to make conflicts of interest more palatable by referring to them as partnerships.

### **Internationally** - The **Global Alliance for Vaccines and Immunisation**

*" . . . with the help of a US \$750 million five-year pledge from the Bill & Melinda Gates Foundation, in January 2000 the Global Alliance for Vaccines and Immunisation (GAVI) was created. A unique public-private partnership, GAVI was created to bring together the best of what key UN agencies, governments, the vaccine industry, private sector and civil society had to offer in order to improve childhood immunisation coverage in poor countries and to accelerate access to new vaccines."<sup>16</sup>*

*The [GAVI] alliance raises a single fund to support global immunization efforts, then channels that funding into vaccination programs meeting criteria determined by alliance partners. The result has been coordinated programs, efficient use of funding and a large pooled market for vaccines . . .*<sup>17</sup>

The health and well being of our children relies on our ability to face reality and act accordingly as vaccine profiteers organize and mobilize to expand the market for these toxic, unwarranted pharmaceuticals:

- Toxic - they contain neurotoxins such as mercury, aluminum and formaldehyde
- Unwarranted - drug companies are not liable for any harm or injury vaccines cause, so there is no warranty that they are either safe or effective
- Pharmaceuticals - artificially created patentable concoctions not found in nature, i.e. foreign to the human body.

#### **D. OVERVIEW - TEN LITTLE KNOWN FACTS ABOUT THE VACCINATION PROGRAM IN THE UNITED STATES**



1) There are many scientific peer-reviewed papers that have exposed the dangers of many vaccines as well as the herd immunity myth. [See the International Medical Council on Vaccination] And, there is solid evidence that the Centers for Disease Control (CDC) has intentionally kept this information away from public health workers, physicians, legislators and the general public.

2) A 2013 Harvard Study exposed the epidemic of corruption in government institutions by Big Pharma influence and money.

3) Those manufacturing, ordering or administering vaccines have been exempted from liability should the drug cause injury, illness or even death. There is no incentive to ensure vaccines are even effective, which they aren't, let alone safe.

6) The CDC is not a government public health advocacy organization. It is a corporation listed on Dun and Bradstreet<sup>18</sup> and it is headquartered in the STATE OF GEORGIA. The CDC is in partnership with Big Pharma via the CDC Foundation. Therefore, CDC recommendations are influenced by the 'fiscal' health of their corporation and the goals of their Big Pharma partners.

7) Physician or institutional records are frequently reviewed by the STATE public health department, which is also a for-profit corporation listed on Dun and Bradstreet, who receives monetary compensation from the CDC to perform this function. Therefore, the state public health department's recommendations and actions are influenced by the fiscal health of their own corporation.

8) The AMERICAN ACADEMY OF PEDIATRICS and the AMERICAN ACADEMY OF FAMILY PHYSICIANS are not health advocacy organizations. They are trade associations-corporations (listed on Dun and Bradstreet) whose monetary compensation from the vaccine manufacturers contributes to the fiscal health of their corporations.

9) Physicians, who are intentionally misinformed by the CDC and Big Pharma, are paid higher reimbursement rates for each fully vaccinated child. This motivates doctors to a) push vaccines and b) deliberately withhold the vaccine package insert, which lists side effects and adverse reactions, from their patients, even when requested. 





I take no pleasure in this conclusion, which I reached slowly and reluctantly over my two decades as an editor of the New England Journal of Medicine.” – Dr. Marcia Angell.

### **CDC partners with Big Pharma<sup>21</sup>**

The CDC Foundation was established to facilitate a collaboration between the CDC and Big Pharma. Big Pharma manufactures vaccines and the CDC pushes them. The use of the term *public-private partnership* is used to cover up the entrenched conflicts of interests that exists between Big Pharma and the CDC.

### **CDC deceives health practitioners as well as the public<sup>22</sup>**

In 2005, Robert Kennedy Jr exposed that in June 2000 a group of top government scientists and health officials gathered for a meeting at the isolated Simpsonwood conference center in Norcross, Georgia. Convened by the Centers for Disease Control, there was no public announcement of the session and the attendees were notified by private invitations.

The federal officials and industry representatives had assembled to discuss a disturbing new study that raised alarming questions about the safety of a host of common childhood vaccines administered to infants and young children. According to a CDC epidemiologist named Tom Verstraeten, they had discovered a link between thimerosal and speech delays, attention-deficit disorder, hyperactivity and autism. The decision was made to conceal the facts and continue to falsely portray vaccines as safe and effective to the public as well as health practitioners.

### **CDC has a dark history of unethical human experimentation<sup>23</sup>**

The CDC was involved with the Tuskegee experiment, which withheld treatment of men with syphilis and increased human suffering for many uniformed innocent men, women and children. No one associated with that CDC experiment was punished or imprisoned.

### **CDC is rife with corruption<sup>24</sup>**

A 2013 Harvard study, *Institutional Corruption of Pharmaceuticals and the Myth of Safe and Effective Drugs*, warned that over the past 35 years, patients have suffered from a largely hidden epidemic of side effects from drugs that usually have few, offsetting benefits.

This study, published in the Journal of Law, Medicine and Ethics, conducted by Light, Lexchin and Darrow, warns that the pharmaceutical industry has corrupted the practice of medicine through its influence over what drugs are developed, how they are tested, and how medical knowledge is created.

The researchers warn that since 1906, commercial influence has compromised Congressional legislation to protect the public from unsafe drugs, adding that the authorization of user fees in 1992 has turned drug companies into the FDA's prime clients, deepening the regulatory and cultural capture of the agency.

### **CDC orchestrates propaganda campaigns based on nonexistent threats<sup>25</sup>**

CBS reporter Sharyl Atkisson investigated and revealed the truth about the fake swine flu epidemic of 2009:

*"If you've been diagnosed "probable" or "presumed" 2009 H1N1 or "swine flu" in recent months, you may be surprised to know this: odds are you didn't have H1N1 flu. In fact, you probably didn't have flu at all. That's according to state-by-state test results obtained in a three-month-long CBS News investigation."*

### **CDC wastes millions of dollars<sup>26</sup>**

*WASHINGTON (2007) — A Republican senator Tuesday released a report critical of spending at the federal Centers for Disease Control and Prevention (CDC), saying the agency "has wasted and continues to waste hundreds of millions of tax dollars, but keeps asking taxpayers for more."*

### **CDC hires researchers to create bogus studies<sup>27</sup>**

A central figure behind the Centers for Disease Control's claims disputing the link between vaccines and autism and other neurological disorders has disappeared after officials discovered massive fraud involving the theft of millions in taxpayer dollars. Danish police are investigating Dr. Poul Thorsen, who has vanished along with almost \$2 million that he had supposedly spent on research.

Thorsen was a leading member of a Danish research group that wrote several key studies supporting the CDC's claims that the MMR vaccine and mercury-laden vaccines were safe for children.

Thorsen's partner Kreesten Madsen recently came under fierce criticism after damning e-mails surfaced showing Madsen in cahoots with CDC officials intent on fraudulently cherry-picking facts to prove vaccine safety.

### **CDC hires private think-tanks to produce manipulated consensus reports<sup>28</sup>**

The U.S. Department of Health and Human Services (DHHS) enlisted the help of a controversial corporate-funded think tank, RAND Corporation, to conduct a "systematic review of the literature" on the safety of federally-recommended vaccines: *Safety of Vaccines Used for Routine Immunization in the United States* (July 1, 2014)<sup>29</sup>

#### *Review Methods*

*We reviewed the methodology of the 2011 Institute of Medicine (IOM) consensus report<sup>30</sup> "Adverse Effects of Vaccines: Evidence and Causality"<sup>31</sup> and accepted their findings.*

In the DHHS-funded and RAND conducted vaccine safety review, 9 out of 10 study authors were employed by RAND, which has served primarily as a Department of Defense contractor since the corporation was founded in 1948. Among RAND's many corporate and government funders are GlaxoSmithKline, a major vaccine manufacturer, and the Bill and Melinda Gates Foundation, which partners with international vaccine corporations and is one of the leading funders and promoters of the global mass vaccination program, Global Alliance for Vaccinations and Immunizations (GAVI).

## **Conclusion**

While most physicians and public health workers may be unaware of the depth of the cover-up regarding vaccines, the harm they are causing is incalculable and the damage being inflicted on us and our children is devastating. Since the illnesses or injuries caused by toxic vaccines frequently don't show up for weeks, months or even years, the medical industrial complex maintains plausible deniability and profits from the chronic diseases they all too often cause.

## PART II - VACCINATION MANDATES AND OPT OUTS

### F. MANDATORY VACCINATIONS

The following contains well-documented information that few attorneys and government employees are aware of and the American people were never meant to understand. As more and more of our population can see that our government accommodates corporations over people, we find ourselves in what feels like a losing battle. It is more evident today than ever before that our health is being sacrificed on the alter of corporate profiteers. We can justifiably refer to them as the **medical industrial complex**.

#### **We need to let go of the myth that government agencies protect us**

As painful and frightening as it might be, unless we face reality our ever-growing loss of true representative government will continue to threaten both our economic and personal health. If we continue to think we can vote our way out of our predicament, which hasn't worked in a very long time, we can legitimately consider ourselves to be insane. After all, the definition of insanity is to do the same thing over and over, expecting different results.

Many vaccine-savvy men and women have called attention to the fact that there has never been a study comparing fully vaccinated children to unvaccinated children, thereby making the entire program experimental. While such a comparison has been done for canines by Purdue University,<sup>35</sup> Dr. Colleen Boyle of the CDC admitted to Rep Bill Posey during a Congressional hearing in 2012 that no study comparing the overall health of the vaxxed versus the unvaxxed has been done. Therefore, the entire mass vaccination program is essentially experimental.

#### **The Nuremburg Code**

Many attorneys believe that the combination of the experimental nature of vaccines, with the lack of informed consent by the parent or patient, is a violation of the Nuremburg Code. This belief gives some folks hope that some form of litigation might stop the growing movement to force vaccinations on the entire population. Unfortunately the Code as a legal document, that was produced as part of an international criminal trial, has no legal force. Even as a document written by judges, it is to be entirely self-enforced. The Code establishes no outside compliance review or method of sanctioning non-compliance.<sup>36</sup> There exists no law or treaty which would allow the courts to enforce it. Perhaps, this explains why the CDC has never done a vaxxed versus unvaxxed study of childhood vaccines.

## The legal status of ourselves and our children

What none of us were taught in school is the indisputable fact that the United States is a Federal corporation<sup>37</sup> and that it went into bankruptcy in 1933. This can be verified in the Congressional Record<sup>38</sup> and by the work of Representative Louis McFadden<sup>39</sup> who witnessed the events from a front row seat on the House Banking Committee. Per the Congressional Record, during the FDR administration a national emergency was declared and all United States 'citizens' were made enemies of the state to justify the confiscation of the people's gold. Our status has not changed since then as the state of national emergency has never been discontinued.<sup>40 41</sup>

Because we are still officially enemies of the state, we are required to register our property and acquire licenses or permits from the government to do just about anything. Government institutions even get us to register our babies before we take them home from the hospital by having us fill out and sign a Certificate of Live Birth. The registration of our children creates the presumption that our so-called government has a parental-type interest in their care. This is known as the *parens patriae* doctrine which was referred to in the *Prince vs. Massachusetts* Supreme Court decision of 1944.<sup>42</sup>

*Parens patriae* definition from legal-dictionary (thefreedictionary.com)<sup>43</sup>

*In the United States, the parens patriae doctrine has had its greatest application in the treatment of children, mentally ill persons, and other individuals who are legally incompetent to manage their affairs. The state is the supreme guardian of all children **within its jurisdiction**, and state courts have the inherent power to intervene to protect the best interests of children whose welfare is jeopardized by controversies between parents. This inherent power is generally supplemented by legislative acts that define the scope of child protection in a state.*

However, their interest in our sons and/or daughters is vested in the name they created on their Birth Certificates, not in the actual living flesh and blood beings that we care for and nurture. We own the physical boys and girls that we created . . . not the corporate government. Corporations cannot own living beings. We cannot lose sight of that critically important fact.

The name in all caps on the government issued Birth Certificate represents the legal juristic *person* that the **government owns**. Because they own it, they can make regulations for it . . . and they do. These rules and regulations today are called statutes and all of our courts have been converted into statutory courts. This new legal system replaced constitutional law and was done by stealth during the ongoing state of national emergency. Big problem however, the American people did not make this decision, nor were they told this change had been implemented. Even most attorneys are not aware of the current status of our courts, which administer statutory (maritime) law. This fact was exposed by law professor/investigator Melvin Stamper in his amazing book *Fruit from a Poisonous Tree*.<sup>44</sup>

*In fact, this establishes a system of law that is based on maritime principles.<sup>45</sup> Unknown to Americans, all courts of the United States - state and federal - are being operated under the principles of such law.*

Beware of ANY attorneys citing Constitutional law, as they are living in a false paradigm. Just ask them to explain Senate Report 93-549<sup>46</sup>, which exposes how over 600 federal agencies unconstitutionally make laws and/or regulations on a daily basis. Most attorneys will not acknowledge the ongoing state of national emergency exposed in this 1973 Senate Report, that was renewed by President Trump on October 20, 2018.<sup>47</sup> They pretend it doesn't matter . . . when it matters very much! This Senate Report was compiled by a very credible group of investigators, including "expert constitutional authorities."

*(pg 3) The Special Committee on the Termination of the National Emergency was created to examine the consequences of terminating the declared states of national emergency that now prevail . . .*

*In accordance with this mandate, the Special Committee-in conjunction with the Executive branch, expert constitutional authorities, as well as former high officials of this Government is now engaged in a detailed study to determine the most reasonable ways to restore normalcy to the operations of our Government.*

In 1944 the mandatory vaccine monster was created and released. This was done with the Supreme Court Prince vs. Massachusetts decision:

*"Neither rights of religion nor rights of parenthood are beyond limitation. Acting to guard the general interest in youth's well being, the state as parens patriae may restrict the parent's control by requiring school attendance, regulating or prohibiting the child's labor, and in many other ways. Its authority is not nullified merely because the parent grounds his claim to control the child's course of conduct on religion or conscience.*

*Thus, he cannot claim freedom from compulsory vaccination for the child more than for himself on religious grounds. The right to practice religion freely does not include liberty to expose the community or the child to communicable disease or the latter to ill health or death. (321 U.S. at 166-7, 64 S.Ct. at 442)"*

This decision was officially reaffirmed in August, 2016 by Judge Sabraw, US District Court, California.<sup>48</sup> No constitutional challenge to mandatory vaccinations has succeeded since 1944, because the Supreme Court refuses to revisit the issue, which unfortunately is their prerogative.

## **Thinking out of the box**

For many years well-informed parents have been asking permission for their child (children) to be excused from mandatory school vaccinations and have been granted exemptions from the statutory rules. However, those days are coming to an end. Several states so far have removed this *privilege* (Judge Sabraw's word, not mine) and more are moving in the same direction. Now, we have to think out of the box and start challenging the state's presumed authority to demand that we inoculate our sons and daughters with toxic unwarranted pharmaceutical products.

## **G. THE ELEPHANTS IN THE ROOM**

### **1. The liability (cost for care) is left on the parent's, patient's, student's or employee's shoulders**

In 1986 Big Pharma threatened to stop producing vaccines due to the increasing number of lawsuits being levied on them by parents of vaccine injured children and the adults who suffered post-vaccination Guillain-Barré syndrome. Tragically Congress kept the vaccine industry alive by passing the National Childhood Vaccine Injury

Act. This Act moved vaccine injury compensation from the manufactures shoulders onto those of the Department of Health and Human Services, which incidentally holds a patent on at least one vaccine product. While this action has given some parents financial relief, it created a liability exemption for Big Pharma's division of vaccines. And parents whose children are vaccine injured must hire their own attorneys to file claims in an administrative court, whose goings-on are private. What transpires in vaccine court cannot be referred to as justice.

In 2011 the insane Supreme Court granted Big Pharma total relief of all liability regarding both the safety and effectiveness of their vaccine products in the Bruecewitz vs. Wyeth decision.

The end result is that vaccines are not warranted by their manufacturers as either safe or effective . . . because the industry has been relieved of that burden. Vaccines have truly become an unwarranted pharmaceutical product that is currently being forced onto an intentionally uninformed public.

While informed consent is required for all other treatments and procedures in the medical industry, many doctors, nurses and pharmacists wrongly believe that vaccines are exempted from this requirement.

From MedlinePlus.gov:<sup>49</sup>

*An important patient right is informed consent. This means that if you need a treatment, your health care provider must give you the information you need to make a decision.*

So, it is up to us to insist they provide us with the information (package insert) we need to give informed consent or dissent.

There is no legally binding way that liability for the harm or injury a vaccine can cause can be forced onto the parent, patient, student or employee - without their consent. The liability (costs for treatment or care) is the **HOT POTATO** that must be tossed back to those that are insisting on vaccination compliance. And, there is a way to do this.

## **2. Statutes are written for "persons"**

STATE statutory vaccination mandates are written for dead legal fiction *persons* (not flesh and blood living men and women and their progeny), which includes corporations and trusts, etc. Although most of the general population is unaware of this **FACT**, it is undeniably true never-the-less.

Honest attorneys cannot discount the following examples, though they will most likely try to dismiss them. Exposing this legal duplicity to the general public might very well cost them their BAR cards.

- SB 277, passed in the STATE OF CALIFORNIA (2015), changed the state's HEALTH AND SAFETY CODE to read: *SEC. 2. Section 120335 of the Health and Safety Code is amended to read:*
  - (a) *As used in this chapter, "governing authority" means the governing board of each school district or the authority of each other private or public institution responsible for the operation and control of the institution or the principal or administrator of each school or institution.*
  - (b) *The governing authority shall not unconditionally admit any **person as a pupil** of any private or public elementary or secondary school . . .*
- In the STATE OF CALIFORNIA a statutory "person" is defined as:  
Government code Section 1-26  
*17. "Person" includes any person, firm, association, organization, partnership, limited liability company, business trust, corporation, or company.*

- In the STATE OF OHIO a statutory “person” is defined as:  
Ohio Revised Code statutory definitions 1.59  
(C) “Person” includes an individual, corporation, business trust, estate, trust, partnership, and association.
- [Uniform Commercial Code] UCC Article 1 - General Provisions define "person" as:  
§ 1-201. General Definitions  
(27) "Person" means an individual, corporation, business trust, estate, trust, partnership, limited liability company, association, joint venture, government, governmental subdivision, agency or instrumentality, public corporation, or any other legal or commercial entity.

Note: none of the entities listed to define "persons" are alive. It should be obvious to all that the rules for 1) artificial legal constructs (such as corporations and trusts) don't apply to 2) living men and women or boys and girls, i.e. the first being dead and the second being alive. You cannot vaccinate a trust or a corporation.

## H. STATE VACCINATION EXEMPTIONS

Many men and women are so unfamiliar with statutory reality that they prefer to agree that their sons and daughters are legal fiction persons and simply wish to use the statutory exemptions – their STATE legislators have passed – to protect their offspring from being injected with toxic unwarranted pharmaceutical products in order to attend school. The following information has been compiled for this relatively large group of well intentioned vaccine-savvy moms and dads.

Over the past decade or more, exemptions from school mandated vaccinations have become increasingly more difficult to obtain. Some states have eliminated all exemptions except those with a provable medical contraindication signed by a licensed physician.

The exemption landscape is rapidly changing even more as the Centers for Disease Control pushes the HEALTHY PEOPLE 2020 program. Lobbyists for the CDC and Big Pharma are swarming all over state legislatures to convince them to eliminate all but medical exemptions. It has literally become *Vaccine Mania* as public health employees feverishly partner with the CDC and drug companies to get us all fully vaccinated. Pro-vaccination messages are now appearing in the news media as well as embedded in TV series and movies.

In the past, some non-profit organizations have researched statutes for each state and have posted exemption rules on their web sites. Today however, parents need to check the up-to-date rules themselves before submitting any exemption letter or form. We can't presume that any non-profit organization has the staff to track all fifty states and provide all of the information needed.

To search for up-to-date information on school exemptions, type in the name of your state followed by the words *code – immunizations* for example:

This search should take you to the exemption information for your state. To be certain that the public health department in your state has not taken it upon themselves to alter the statutes to suit their own goals (a common

practice), look for the number of the statute that was passed by the STATE legislature. It is usually preceded by the symbol § for section. With a little effort you can locate the statute and read it for yourself.

### Forms and Waivers

If your STATE has an exemption form or waiver, print it out and examine it closely. Some exemption forms ask you to check boxes for statements that you will not agree with. DON'T IGNORE THIS DILEMMA<sup>50</sup>, for it will be assumed that you concur with what could very well be false or misleading statements. The STATE OF CALIFORNIA's now extinct *Personal Beliefs Exemption to Required Immunizations* form of 10/13 is a perfect example of this. In Section B the form required the parent to confirm this statement with their signature:

***Religious beliefs:** I am a member of a religion which prohibits me from seeking medical advice or treatment from authorized health care practitioners.*

Just because your religious beliefs prohibit you from injecting your son or daughter with toxic unwarranted pharmaceutical products does not mean that if your child broke his/her leg you wouldn't have it set. And, exactly what is an "authorized health care practitioner"? If I were to use this form, I would modify it:

***Religious beliefs:** I am a member of a religion which prohibits me from ~~seeking medical advice or treatment from authorized health care practitioners~~. Write in: *injecting my son (or daughter) with unwarranted pharmaceutical products.**

If the form or waiver asks you to list the vaccines you are requesting an exemption from, do not mark the individual boxes but write across them *all unwarranted vaccines*. Since the Supreme Court decision *Bruesewitz vs Wyeth* (2011), no vaccine product is warranted as either safe or effective

Again, as long as moms and dads don't challenge false or misleading statements on exemption/waiver forms, it will be assumed they agree with them. Should any employee of the school or public health department tell you that their forms cannot be altered, **politely ask them for the number of the state statute that prohibits initialed clarifications**. While these employees are bound by the rules of their employers, parents are not and should not hesitate to challenge their inane rules. If they don't accept your appropriately modified waiver, move on to a **Vaccination Notice**.

## I. THE VACCINATION NOTICE - LET'S MAKE A DEAL

Notices are available as alternatives to exemptions and are in many ways superior . . . especially if the exemption form requires that you agree with statements you know to be false.

As vaccination recommendations, requests and requirements mount, we will need new ways to protect ourselves from vaccine mania. We are going to have to place our well-informed decision to refuse vaccines on the record. A legal notice can help accomplish this.

*The concept of notice is critical to the integrity of legal proceedings. Due process requires that legal action cannot be taken against anyone unless the requirements of notice and an opportunity to be heard are observed.*

In the current statutory legal system (the Uniform Commercial Code) that our legislatures and courts function under, the **NOTICE** plays an important role. It is a well recognized device to inform interested parties.

From Uniform Commercial Code] UCC Article 1 - General Provisions

**§ 1-202. Notice; Knowledge.**

(a) Subject to subsection (f), a person has "notice" of a fact if the person: (1) has actual knowledge of it; (2) has received a notice or notification of it; or (3) from all the facts and circumstances known to the person at the time in question, has reason to know that it exists.

(b) "Knowledge" means actual knowledge. "Knows" has a corresponding meaning.

(c) "Discover", "learn", or words of similar import refer to knowledge rather than to reason to know.

(d) A person "notifies" or "gives" a notice or notification to another person by taking such steps as may be reasonably required to inform the other person in ordinary course, whether or not the other person actually comes to know of it.

An important part of giving notice is to state the facts regarding the player's corporate status. Exposing that government entities and agencies are merely corporations is the surest way to question their authority.

Reminder:

According to 28 US Code § 3002 - Definitions:

(15) United States means -

(A) a Federal Corporation;

(B) an agency, department, commission, board, or other entity of the United States; or

(c) an instrumentality of the United States.

The list of corporate entities and instrumentalities includes the STATE OF, COUNTY, MUNICIPALITY, the FDA, the CDC, the EPA, the USDA, the FCC and on and on.

The Vaccination Notice also allows you the opportunity to educate those requesting the vaccination, as an enormous system of propaganda regarding vaccines has been in place for a very long time. For the most part those requesting vaccinations (schools, hospitals, military, employers, etc.) believe these toxic concoctions are benign and beneficial (safe and effective). Most vaccination requesters don't know or understand that:

- \* The public health department, the CDC and the state are all corporations. Basically our entire government is a franchised network of corporations.
- \* Physicians get more money for each 'fully vaccinated' child in their practice.
- \* Those manufacturing and administering vaccines have been given an exemption for liability should these concoctions cause injury, illness or even death. This unjustly places the costs (liability) of any injury or loss onto the parent, patient, student or employee – not on the vaccine requester.
- \* Most vaccine requesters intentionally withhold the vaccine package insert thus denying the parent, patient, student or employee real information about the health risks they are being asked to take. There are even documented cases of parents being jailed for injuries that resulted from childhood vaccines – injuries that were listed on the package insert that the parent never received.

The Vaccination Notice contains all four of these little known facts.

It is important to save a copy of your notice should efforts to force compliance of a rule/regulation continue. Notices can be hand delivered, sent by certified mail (with a return receipt) or published in the newspaper with other legal notices. Notices can be used to address many issues, but the implementation and text changes a bit depending on who you are noticing. So, locate the one that best applies to your situation. We have sample notices for the following:

- (1) Parents to give to pediatricians and/or hospitals  
The Vaccination Notice for Physicians or Hospitals
- (2) Parents to give to schools or daycares  
The Vaccination Notice for Schools or Daycares

- (3) Employees or college enrollees to give to employers or colleges/universities  
The Vaccination Notice for Employers or Deans

Printing out both the instructions and the sample notice is advised to thoroughly familiarize oneself with the content and implementation of this strategy.

## 1) THE VACCINATION NOTICE FOR PHYSICIANS AND HOSPITALS

### For parents and/or patients

Before submitting a vaccination notice to your physician or hospital, request the package insert for the vaccine they wish to give. Do not accept Centers for Disease Control (CDC) Vaccine Information Sheets as a substitute. The CDC readily admits that these sheets are not designed to be a substitute for informed consent. Be prepared for resistance. Understand that generally there are monetary incentives for both the physician and the hospital to get as many as possible vaccinated. After reading the package insert (you will be shocked), politely tell the nurse or doctor that you are not comfortable with the risks.

### Refusal to Vaccinate

If asked to sign a *Refusal to Vaccinate* form, decline the offer. If they insist, say you will take it home and discuss it with your family. Then go to [ParentsAgainstMandatoryVaccines.net](http://ParentsAgainstMandatoryVaccines.net) and put **Do Not Sign** in the search box. The form and its implications are spelled out in detail. Many physicians are inclined to eliminate children from their practice if the parent refuses vaccines and refuses to sign their form. These physicians have been told that the *Refusal to Vaccinate* form will protect them from being sued should a child get one of the many "dread diseases" (not) the vaccines are supposed to prevent. The *Refusal to Vaccinate* form was designed to protect the physician and put the parent in jeopardy. Giving the physician a Vaccination Notice should break this stale mate.

### Let's Make a Deal

The Vaccination Notice is designed to inform the doctor or hospital the reasons you are opposed to the vaccine, but that you will consent if they agree to accept the liability - in writing, **which their lawyers would never let them do**. The **VACCINATION NOTICE FOR PHYSICIANS AND HOSPITALS (a)** was designed for parents to use and the **VACCINATION NOTICE FOR PHYSICIANS AND HOSPITALS (b)** was designed for adult patients to use.

The statements listed on the notice are factual and easy to validate. This approach should help put an end to the harassing discussions that physicians and others inflict on vaccine-savvy parents and patients.

### FILLING OUT THE NOTICE

1. Items in [brackets] need to be personalized.
2. Select son or daughter as applicable.
3. Corporate entities need to be in all caps.
4. The health department of each state is listed in its corporate name in all caps on Dun and Bradstreet. That information is accessible for free online.
5. At the bottom of the notice is a space for the parent's signature and the signature of two witnesses. Of course the dates need to be identical. A notary is an acceptable alternative.

**It is essential to read, understand and agree with the notice before you sign and deliver it.**

### DELIVERING THE NOTICE

This notice requires little discussion. Just hand it to the nurse or doctor. Politely explain that you are not comfortable with the vaccine risks and wish to have this notice placed in [the child's or your] record so you don't have to bring in a new one each time you visit. If asked where you obtained the document, simply say from another parent or patient, which is true. Giving more information is neither required nor advisable. Citing websites or vaccine-savvy organizations just motivates those in the vaccination-distribution business to track down and discredit folks that are doing their best to bring good information to the public. Frankly, where you get your information is none of their business.

Do not answer detailed questions about your objections to any vaccine. Just repeat what is on the notice; "I will consent to the vaccine, if you will accept the liability". Keep a copy for yourself and write the date and the name of the employee who accepted it.

Should the clerk, doctor, or nurse refuse to accept your notice, remind them that legal notices are an integral part of our legal system. Write the date and the name of the individual who rejected it on the notice. Then take the notice home and send it certified mail (with return receipt) to the doctor's office, with a Post-It stating: *for Joey Doe's patient chart* Keep a copy of the notice with the Certified Mail number on it.

## **(2) THE VACCINATION NOTICE FOR SCHOOLS OR DAYCARES**

The Vaccination Notice is designed to notify the school of the reasons you do not choose to have your son or daughter injected with potentially dangerous products that the manufacturer doesn't stand behind. You refuse to accept the liability for any vaccine injury or illness that might occur from the vaccination(s).

### **Let's Make a Deal**

The Vaccination Notice informs the school superintendent or daycare administrator that you will consent to their vaccination request if they agree to accept the liability - in writing, **which their lawyers would never let them do**. The statements listed on the notice are factual and easy to validate. The Governor is included on this notice as it is the Governor that must sign the vaccine mandates passed by the legislature into law. This approach should allow the school or daycare the instrument they need to exclude your child from the statutory vaccine mandates.

### **FILLING OUT THE NOTICE**

1. Items in [brackets] need to be personalized.
2. Select son or daughter as applicable.
3. Corporate entities need to be in all caps.
4. The health department of each state is listed in its corporate name in all caps on Dun and Bradstreet. That information is accessible for free online.
5. At the bottom of the notice is a space for the parent's signature and the signature of two witnesses. Of course the dates need to be identical. A notary is an acceptable alternative.

**It is essential to read, understand and agree with the notice before you sign and deliver it.**

### **DELIVERING THE NOTICE**

The notice requires little discussion. Just hand it to the clerk responsible for the collection of student paperwork. Explain that it is a lawful notice to be placed in your child's record. Should you be asked where you obtained the notice, simply say from another parent, which is true. Giving more information is not required nor recommended. Citing websites or vaccine aware groups or authors just serves to motivate those in the vaccination-distribution business to track down and discredit (or worse) the folks that are doing their best to bring good information to the public. The less said the better. Let the notice speak for you.

Should the clerk refuse, politely remind him/her that that decision is not his/hers to make as the notice is for both the "agent" and the "principal". You may have to remind the employee that neither the clerk nor his/her supervisor can make decisions for the "principal". Keep a copy of the notice for yourself. Always always always remain polite.

Should the school employee refuse to place the notice in the record, write on the Vaccination Notice "refused by agent (name) on (date)" in the space at the top of the notice. Then take it home and send it certified mail (with the certification # on it) with a return receipt on the envelope to the Superintendent (or head administrator). Keep a copy. Include a short explanatory letter, to the effect of:

*On such and such a date I presented my Vaccination Notice to the agent in charge of school registration paperwork by the name of (name). She refused to accept and forward it to your office. Therefore it is enclosed. Please process it accordingly.*

### **(3) THE VACCINATION NOTICE FOR EMPLOYERS OR DEANS**

#### **Let's Make a Deal**

The following notices are designed to inform employers or collages of the conditions under which employees or students will comply with flu shot (or other vaccine) requests. Remember that there have been adults who were permanently severely disabled by vaccines (research Guillian-Barré ) - whose employers paid zero in compensation! And for this very reason drug companies refused to stop making vaccines unless they were given immunity from liability. Therefore, **it is extremely unlikely your employer will provide a document accepting liability** should you suffer illness or injury from the vaccine. Their attorneys will instruct them to avoid it like the plague.

Before filling out and turning in this notice, employees and or students should request the vaccine package insert (don't settle for the CDC Vaccination Information Sheet) for the vaccine they are being asked to take. If the appropriate insert is provided, inform the employer that you must take it home to read and consider. **DO NOT JUST READ IT AND HAND IT BACK.** It could be used as evidence should you choose to accept the vaccine . . . and get injured by it.

If the package inset is provided, fill out and submit **VACCINATION NOTICE FOR EMPLOYERS OR DEANS (a)**. If no insert is provided use **VACCINATION NOTICE FOR EMPLOYERS OR DEANS (b)**. These Vaccination Notices were designed to help employees or students decline flu shot (or other vaccine) requests . . . and hopefully keep their jobs or their college enrollment.

#### **FILLING OUT THE NOTICE**

1. Items in [brackets] need to be personalized.
2. Select employee or student as applicable.
3. Corporate entities need to be in all caps.
4. At the bottom of the notice is a space for the employee or student's signature and the signature of two witnesses. Of course the dates need to be identical. A notary is an acceptable alternative.

**It is essential to read, understand and agree with the notice before you sign and deliver it.**

#### **DELIVERING THE NOTICE**

This notice requires little discussion. Just hand it to the department that notified the employee/student of the vaccine request. Politely explain that you are not yet able to make a decision regarding the vaccine request and you wish to notify them of the additional assurances you require before complying. If asked where you obtained the notice, simply say from another individual who shares your concerns, which is true. Giving more information is not required and is not advisable. Citing websites or vaccine aware organizations just motivates those in the well funded vaccination-distribution business to track down and discredit folks that are doing their best to bring good information to the public. Always be polite and appear cooperative.

The notice just states indisputable facts and is designed to be self-explanatory. However, if you don't understand all of the items on the notice and agree they are factual, do not use it.

Keep a copy of the notice for yourself and write the name of the individual you gave it to and the date on the bottom of the notice. Should you be told your employer will not accept this notice, ask if they would prefer you sent it by certified mail directly to the head of the department or the Dean.
